LIST OF ACQUIS SUBJECT TO SIMPLIFIED PROCEDURE

To be noted by the EEA Joint Committee

1. Simplified procedures¹ have been introduced in the food and veterinary field². These procedures imply that certain acts are applicable to the EEA EFTA countries without being incorporated into the EEA Agreement. In this way, the EEA EFTA States will simultaneously with the EU Member States take corresponding measures on the basis of relevant Union acts. The Union decisions may be taken note of by the EEA Joint Committee. These acts are not to apply to Liechtenstein.
2. In the Veterinary field, the procedures apply to application texts and lists of establishments related to import from third countries and to safeguard and protective measures. As to emergencies for food and feed of European Union origin or imported from a third country, Art. 53 and 54 of Regulation (EC) No 178/2002 apply as of the entry into force on 1 May 2010 of Joint Committee Decision No 134/2007.
3. The EEA Joint Committee is invited, at its meeting on 4 February 2022, to take note of 23 EU acts published in the Official Journal of the European Union in the 4th quarter 2021 in the veterinary field (Annex I) and two EU acts adopted in accordance with Articles 53 and 54 of Regulation No 178/2002 (Annex II).
