#### LIST OF ACQUIS SUBJECT TO SIMPLIFIED PROCEDURE

#### To be noted by the EEA Joint Committee

- 1. Simplified procedures<sup>1</sup> have been introduced in the food and veterinary field<sup>2</sup>. These procedures imply that certain acts are applicable to the EEA EFTA countries without being incorporated into the EEA Agreement. In this way, the EEA EFTA States will simultaneously with the EU Member States take corresponding measures on the basis of relevant Union acts. The Union decisions may be taken note of by the EEA Joint Committee. These acts are not to apply to Liechtenstein.
- 2. In the Veterinary field, the procedures apply to application texts and lists of establishments related to import from third countries and to safeguard and protective measures. As to emergencies for food and feed of European Union origin or imported from a third country, Art. 53 and 54 of Regulation (EC) No 178/2002 apply as of the entry into force on 1 May 2010 of Joint Committee Decision No 134/2007.
- 3. The EEA Joint Committee is invited, at its meeting on 12 June 2024, to take note of 28 EU acts published in the Official Journal of the European Union in the 1st quarter 2024 in the veterinary field (Annex I).
