SUBCOMMITTEE I ON THE FREE MOVEMENT OF GOODS LIST OF ACQUIS SUBJECT TO SIMPLIFIED PROCEDURE

To be noted by the EEA Joint Committee

- 1. Simplified procedures¹ have been introduced in the food and veterinary field². These procedures imply that certain acts are applicable to the EEA EFTA countries without being incorporated into the EEA Agreement. In this way, the EEA EFTA States will, simultaneously with the EU Member States take corresponding measures on the basis of relevant Union acts. The Union decisions may be taken note of by the EEA Joint Committee. These acts are not to apply to Liechtenstein.
- 2. In the Veterinary field, the procedures apply to application texts and lists of establishments related to import from third countries and to safeguard and protective measures. As to emergencies for food and feed of European Union origin or imported from a third country, Art. 53 and 54 of Regulation (EC) No 178/2002 apply.
- 3. The EEA Joint Committee is invited, at its meeting on 11 December 2020, to take note of 16 EU acts published in the Official Journal of the European Union in the 3rd quarter 2020 in the veterinary field (Annex I).
