DECISION OF THE EEA JOINT COMMITTEE

No 32/2014

of 14 February 2014

amending Annex XX (Environment) to the EEA Agreement

THE EEA JOINT COMMITTEE,

Having regard to the Agreement on the European Economic Area ('the EEA Agreement'), and in particular Article 98 thereof,

Whereas:

- Commission Regulation (EC) No 1418/2007 of 29 November 2007 concerning the export for recovery of certain waste listed in Annex III or IIIA to Regulation (EC) No 1013/2006 of the European Parliament and of the Council to certain countries to which the OECD Decision on the control of transboundary movements of wastes does not apply (1) is to be incorporated into the EEA Agreement.
- (2) Commission Regulation (EC) No 740/2008 of 29 July 2008 amending Regulation (EC) No 1418/2007 as regards the procedures to be followed for export of waste to certain countries (2) is to be incorporated into the EEA Agreement.
- Commission Regulation (EC) No 967/2009 of 15 October 2009 amending Regulation (EC) No 1418/2007 (3) concerning the export for recovery of certain waste to certain non-OECD countries (3) is to be incorporated into the EEA Agreement.
- Commission Regulation (EU) No 837/2010 of 23 September 2010 amending Regulation (EC) No 1418/2007 concerning the export for recovery of certain waste to certain non-OECD countries (4) is to be incorporated into the EEA Agreement.

HAS ADOPTED THIS DECISION:

Article 1

The following is inserted after point 32ca (deleted) of Annex XX to the EEA Agreement:

Article 3

This Decision shall enter into force on 15 February 2014, provided that all the notifications under Article 103(1) of the EEA Agreement have been made (*).

Article 4

This Decision shall be published in the EEA Section of, and in the EEA Supplement to, the Official Journal of the European Union.
