# DECISION OF THE EEA JOINT COMMITTEE No 156/2014

### of 9 July 2014

## amending Annex XXII (Company law) to the EEA Agreement [2015/91]

THE EEA JOINT COMMITTEE,

Having regard to the Agreement on the European Economic Area ('the EEA Agreement'), and in particular Article 98 thereof.

#### Whereas:

- (1) Commission Implementing Decision 2013/280/EU of 11 June 2013 on the adequacy of the competent authorities of the United States of America pursuant to Directive 2006/43/EC of the European Parliament and of the Council (¹) is to be incorporated into the EEA Agreement.
- (2) Commission Implementing Decision 2013/281/EU of 11 June 2013 on the equivalence of the public oversight, quality assurance, investigation and penalty systems for auditors and audit entities of the United States of America pursuant to Directive 2006/43/EC of the European Parliament and of the Council (²) is to be incorporated into the EEA Agreement.
- (3) Annex XXII to the EEA Agreement should therefore be amended accordingly,

HAS ADOPTED THIS DECISION:

## Article 1

The following points are inserted after point 10fd (Commission Decision 2011/30/EU) of Annex XXII to the EEA Agreement:

- '10fe. **32013 D 0280**: Commission Implementing Decision 2013/280/EU of 11 June 2013 on the adequacy of the competent authorities of the United States of America pursuant to Directive 2006/43/EC of the European Parliament and of the Council (OJ L 161, 13.6.2013, p. 4).
- 10ff. **32013 D 0281**: Commission Implementing Decision 2013/281/EU of 11 June 2013 on the equivalence of the public oversight, quality assurance, investigation and penalty systems for auditors and audit entities of the United States of America pursuant to Directive 2006/43/EC of the European Parliament and of the Council (OJ L 161, 13.6.2013, p. 8).'

## Article 2

The texts of Implementing Decisions 2013/280/EU and 2013/281/EU in the Icelandic and Norwegian languages, to be published in the EEA Supplement to the Official Journal of the European Union, shall be authentic.

#### Article 3

This Decision shall enter into force on 10 July 2014, provided that all the notifications under Article 103(1) of the EEA Agreement have been made (\*).
