

DECISION OF THE EEA JOINT COMMITTEE
No 272/2015
of 30 October 2015
amending Annex XIII (Transport) to the EEA Agreement [2017/1061]

THE EEA JOINT COMMITTEE,

Having regard to the Agreement on the European Economic Area ('the EEA Agreement'), and in particular Article 98 thereof,

Whereas:

- (1) Commission Regulation (EU) No 1304/2014 of 26 November 2014 on the technical specification for interoperability relating to the subsystem 'rolling stock — noise' amending Decision 2008/232/EC and repealing Decision 2011/229/EU ⁽¹⁾ is to be incorporated into the EEA Agreement.
- (2) Annex XIII to the EEA Agreement should therefore be amended accordingly,

HAS ADOPTED THIS DECISION:

Article 1

Annex XIII to the EEA Agreement shall be amended as follows:

1. The following indent is added in points 37ah (Commission Decision 2008/232/EC) and 37g (Commission Decision 2011/229/EU):

‘— **32014 R 1304**: Commission Regulation (EU) No 1304/2014 of 26 November 2014 (OJ L 356, 12.12.2014, p. 421).’

2. The following is inserted after point 37ah (Commission Decision 2008/232/EC):

‘37ai. **32014 R 1304**: Commission Regulation (EU) No 1304/2014 of 26 November 2014 on the technical specification for interoperability relating to the subsystem 'rolling stock — noise' amending Decision 2008/232/EC and repealing Decision 2011/229/EU (OJ L 356, 12.12.2014, p. 421).

The provisions of the Regulation shall, for the purposes of this Agreement, be read with the following adaptations:

- (a) In section 7.3.2.3(a) of the Annex, the words “Norway and” shall be inserted before the word “Sweden”;
- (b) In section 7.3.2.4(a) of the Annex, the words “Norway and” shall be inserted before the word “Sweden”.

Article 2

The texts of Regulation (EU) No 1304/2014 in the Icelandic and Norwegian languages, to be published in the EEA Supplement to the *Official Journal of the European Union*, shall be authentic.

Article 3

This Decision shall enter into force on 1 November 2015, provided that all the notifications under Article 103(1) of the EEA Agreement have been made (*).
