

DECISION OF THE EEA JOINT COMMITTEE**No 108/2017****of 13 June 2017****amending Annex XX (Environment) to the EEA Agreement [2018/803]**

THE EEA JOINT COMMITTEE,

Having regard to the Agreement on the European Economic Area ('the EEA Agreement'), and in particular Article 98 thereof,

Whereas:

- (1) Commission Decision (EU) 2017/175 of 25 January 2017 on establishing EU Ecolabel criteria for tourist accommodation ⁽¹⁾ is to be incorporated into the EEA Agreement.
- (2) Commission Decision (EU) 2017/176 of 25 January 2017 on establishing EU Ecolabel criteria for wood-, cork- and bamboo-based floor coverings ⁽²⁾ is to be incorporated into the EEA Agreement.
- (3) Decision (EU) 2017/175 repeals Commission Decisions 2009/564/EC ⁽³⁾ and 2009/578/EC ⁽⁴⁾, which are incorporated into the EEA Agreement and are consequently to be repealed under the EEA Agreement.
- (4) Decision (EU) 2017/176 repeals Commission Decision 2010/18/EC ⁽⁵⁾, which is incorporated into the EEA Agreement and is consequently to be repealed under the EEA Agreement.
- (5) Annex XX to the EEA Agreement should therefore be amended accordingly,

HAS ADOPTED THIS DECISION:

Article 1

Annex XX to the EEA Agreement shall be amended as follows:

1. The text of point 2m (Commission Decision 2009/578/EC) is replaced by the following:
'**32017 D 0175:** Commission Decision (EU) 2017/175 of 25 January 2017 on establishing EU Ecolabel criteria for tourist accommodation (OJ L 28, 2.2.2017, p. 9).'
2. The text of point 2zb (Commission Decision 2010/18/EC) is replaced by the following:
'**32017 D 0176:** Commission Decision (EU) 2017/176 of 25 January 2017 on establishing EU Ecolabel criteria for wood-, cork- and bamboo-based floor coverings (OJ L 28, 2.2.2017, p. 44).'
3. The text of point 2p (Commission Decision 2009/564/EC) is deleted.

Article 2

The texts of Decisions (EU) 2017/175 and (EU) 2017/176 in the Icelandic and Norwegian languages, to be published in the EEA Supplement to the *Official Journal of the European Union*, shall be authentic.

Article 3

This Decision shall enter into force on 14 June 2017, provided that all the notifications under Article 103(1) of the EEA Agreement have been made (*).
