

**DECISION OF THE EEA JOINT COMMITTEE**  
**No 240/2017**

**of 15 December 2017**

**amending Annex XI (Electronic communication, audiovisual services and information society) to the EEA Agreement**

THE EEA JOINT COMMITTEE,

Having regard to the Agreement on the European Economic Area (“the EEA Agreement”), and in particular Article 98 thereof,

Whereas:

- (1) Commission Implementing Decision (EU) 2017/1438 of 4 August 2017 amending Decision 2007/131/EC on allowing the use of the radio spectrum for equipment using ultra-wideband technology in a harmonised manner in the Community<sup>1</sup> is to be incorporated into the EEA Agreement.
- (2) Commission Implementing Decision (EU) 2017/1483 of 8 August 2017 amending Decision 2006/771 on harmonisation of the radio spectrum for use by short-range devices and repealing Decision 2006/804/EC<sup>2</sup> is to be incorporated into the EEA Agreement.
- (3) Implementing Decision (EU) 2017/1483 repeals, with effect from 1 January 2018, Commission Decision 2006/804/EC<sup>3</sup>, which is incorporated into the EEA Agreement and which is consequently to be repealed under the EEA Agreement with effect from 1 January 2018.
- (4) Annex XI to the EEA Agreement should therefore be amended accordingly,

HAS ADOPTED THIS DECISION:

*Article 1*

Annex XI to the EEA Agreement shall be amended as follows:

1. The following indent is added in point 5cw (Commission Decision 2007/131/EC):  
‘- **32017 D 1438**: Commission Implementing Decision (EU) 2017/1438 of 4 August 2017 (OJ L 205, 8.8.2017, p. 89).’
2. The following indent is added in point 5cz (Commission Decision 2006/771/EC):  
‘- **32017 D 1483**: Commission Implementing Decision (EU) 2017/1483 of 8 August 2017 (OJ L 214, 18.8.2017, p. 3).’

3. The text of point 5cza (Commission Decision 2006/804/EC) shall be deleted with effect from 1 January 2018.

*Article 2*

The texts of Implementing Decisions (EU) 2017/1438 and (EU) 2017/1483 in the Icelandic and Norwegian languages, to be published in the EEA Supplement to the *Official Journal of the European Union*, shall be authentic.

*Article 3*

This Decision shall enter into force on 16 December 2017, provided that all the notifications under Article 103(1) of the EEA Agreement have been made\*.

*Article 4*

This Decision shall be published in the EEA Section of, and in the EEA Supplement to, the *Official Journal of the European Union*.
