

DECISION OF THE EEA JOINT COMMITTEE
No 26/2020

of 7 February 2020

amending Annex XVI (Public Procurement) to the EEA Agreement

THE EEA JOINT COMMITTEE,

Having regard to the Agreement on the European Economic Area (“the EEA Agreement”), and in particular Article 98 thereof,

Whereas:

- (1) Commission Delegated Regulation (EU) 2019/1827 of 30 October 2019 amending Directive 2014/23/EU of the European Parliament and of the Council in respect of the threshold for concessions¹ is to be incorporated into the EEA Agreement.
- (2) Commission Delegated Regulation (EU) 2019/1828 of 30 October 2019 amending Directive 2014/24/EU of the European Parliament and of the Council in respect of the thresholds for public supply, service and works contracts, and design contests² is to be incorporated into the EEA Agreement.
- (3) Commission Delegated Regulation (EU) 2019/1829 of 30 October 2019 amending Directive 2014/25/EU of the European Parliament and of the Council in respect of the thresholds for supply, service and works contracts, and design contests³ is to be incorporated into the EEA Agreement.
- (4) Commission Delegated Regulation (EU) 2019/1830 of 30 October 2019 amending Directive 2009/81/EC of the European Parliament and of the Council in respect of the thresholds for supply, service and works contracts⁴ is to be incorporated into the EEA Agreement.
- (5) Annex XVI to the EEA Agreement should therefore be amended accordingly,

HAS ADOPTED THIS DECISION:

Article 1

Annex XVI to the EEA Agreement shall be amended as follows:

1. The following indent is added in point 2 (Directive 2014/24/EU of the European Parliament and of the Council):
 - ‘- **32019 R 1828:** Commission Delegated Regulation (EU) 2019/1828 of 30 October 2019 (OJ L 279, 31.10.2019, p. 25).’

3. The following indent is added in point 5c (Directive 2009/81/EC of the European Parliament and of the Council):
‘- **32019 R 1830**: Commission Delegated Regulation (EU) 2019/1830 of 30 October 2019 (OJ L 279, 31.10.2019, p. 29).’
4. The following indent is added in point 6f (Directive 2014/23/EU of the European Parliament and of the Council):
‘- **32019 R 1827**: Commission Delegated Regulation (EU) 2019/1827 of 30 October 2019 (OJ L 279, 31.10.2019, p. 23).’

Article 2

The texts of Delegated Regulations (EU) 2019/1827, (EU) 2019/1828, (EU) 2019/1829 and (EU) 2019/1830 in the Icelandic and Norwegian languages, to be published in the EEA Supplement to the *Official Journal of the European Union*, shall be authentic.

Article 3

This Decision shall enter into force on 8 February 2020, provided that all the notifications under Article 103(1) of the EEA Agreement have been made*.

Article 4

This Decision shall be published in the EEA Section of, and in the EEA Supplement to, the *Official Journal of the European Union*.
