# DECISION OF THE EEA JOINT COMMITTEE No 209/2021

## of 9 July 2021

# amending Annex II (Technical regulations, standards, testing and certification) to the EEA Agreement

#### THE EEA JOINT COMMITTEE,

Having regard to the Agreement on the European Economic Area ("the EEA Agreement"), and in particular Article 98 thereof,

#### Whereas:

- (1) Commission Directive (EU) 2019/1922 of 18 November 2019 amending, for the purposes of adaptation to technical and scientific developments, point 13 of part III of Annex II to Directive 2009/48/EC of the European Parliament and of the Council on the safety of toys, as regards aluminium<sup>1</sup> is to be incorporated into the EEA Agreement.
- (2) Commission Directive (EU) 2019/1929 of 19 November 2019 amending Appendix C to Annex II to Directive 2009/48/EC of the European Parliament and of the Council for the purpose of adopting specific limit values for chemicals used in certain toys, as regards formaldehyde<sup>2</sup> is to be incorporated into the EEA Agreement.
- (3) Annex II to the EEA Agreement should therefore be amended accordingly,

### HAS ADOPTED THIS DECISION

#### Article 1

The following indents are added in point 1a (Directive 2009/48/EC of the European Parliament and of the Council) of Chapter XXIII of Annex II to the EEA Agreement:

- '- **32019** L **1922**: Commission Directive (EU) 2019/1922 of 18 November 2019 (OJ L 298, 19.11.2019, p. 5),
- **32019** L **1929**: Commission Directive (EU) 2019/1929 of 19 November 2019 (OJ L 299, 20.11.2019, p. 51).'

#### Article 2

The texts of Directives (EU) 2019/1922 and (EU) 2019/1929 in the Icelandic and Norwegian languages, to be published in the EEA Supplement to the *Official Journal of the European Union*, shall be authentic.
