



DECISION OF THE EEA JOINT COMMITTEE No 222/2021
of 9 July 2021
amending Annex XX (Environment) to the EEA Agreement [2024/278]

THE EEA JOINT COMMITTEE,

Having regard to the Agreement on the European Economic Area ("the EEA Agreement"), and in particular Article 98 thereof,

Whereas:

- (3) Commission Implementing Decision (EU) 2019/1861 ⁽³⁰⁾, which is incorporated into the EEA Agreement, has become obsolete and is consequently to be repealed under the EEA Agreement.
- (4) Annex XX to the EEA Agreement should therefore be amended accordingly,

HAS ADOPTED THIS DECISION:

Article 1

Chapter III of Annex XX to the EEA Agreement shall be amended as follows:

1. The following point is inserted after point 21azh (Commission Implementing Decision (EU) 2020/1232):

Article 2

The text of Implementing Decision (EU) 2020/1806 in the Icelandic and Norwegian languages, to be published in the EEA Supplement to the *Official Journal of the European Union*, shall be authentic.

Article 3

This Decision shall enter into force on 10 July 2021, provided that all the notifications under Article 103(1) of the EEA Agreement have been made *.
