

**DECISION OF THE EEA JOINT COMMITTEE**  
**No 276/2021**

**of 24 September 2021**

**amending Annex XI (Electronic communication, audiovisual services and information society) to the EEA Agreement**

THE EEA JOINT COMMITTEE,

Having regard to the Agreement on the European Economic Area (“the EEA Agreement”), and in particular Article 98 thereof,

Whereas:

- (1) Commission Implementing Regulation (EU) 2019/2243 of 17 December 2019 establishing a template for the contract summary to be used by providers of publicly available electronic communications services pursuant to Directive (EU) 2018/1972 of the European Parliament and of the Council<sup>1</sup>, as corrected by OJ L 16, 21.1.2020, p. 40, is to be incorporated into the EEA Agreement.
- (2) Annex XI to the EEA Agreement should therefore be amended accordingly,

HAS ADOPTED THIS DECISION:

*Article 1*

The following is inserted after point 5czs (Directive (EU) 2018/1972 of the European Parliament and of the Council) of Annex XI to the EEA Agreement:

‘5czs. **32019 R 2243**: Commission Implementing Regulation (EU) 2019/2243 of 17 December 2019 establishing a template for the contract summary to be used by providers of publicly available electronic communications services pursuant to Directive (EU) 2018/1972 of the European Parliament and of the Council, as corrected by OJ L 16, 21.1.2020, p. 40 (OJ L 336, 30.12.2019, p. 274).

The provisions of the Regulation shall, for the purposes of this Agreement, be read with the following adaptations:

In the Annex, as regards the EFTA States:

- (i) In part A, the words “EU law” shall be replaced by the words “the EEA Agreement”;
- (ii) In part B, references to Union law shall be understood as references to the EEA Agreement.’

## *Article 2*

The text of Implementing Regulation (EU) 2019/2243, as corrected by OJ L 16, 21.1.2020, p. 40, in the Icelandic and Norwegian languages, to be published in the EEA Supplement to the *Official Journal of the European Union*, shall be authentic.

## *Article 3*

This Decision shall enter into force on 25 September, provided that all the notifications under Article 103(1) of the EEA Agreement have been made\*, or on the day of the entry into force of Decision of the EEA Joint Committee No 275/2021 of 24 September 2021<sup>2</sup>, whichever is the later.

## *Article 4*

This Decision shall be published in the EEA Section of, and in the EEA Supplement to, the *Official Journal of the European Union*.
