DECISION OF THE EEA JOINT COMMITTEE No 348/2021

of 10 December 2021

amending Annex II (Technical regulations, standards, testing and certification) and Annex IV (Energy) to the EEA Agreement

THE EEA JOINT COMMITTEE,

Having regard to the Agreement on the European Economic Area ("the EEA Agreement"), and in particular Article 98 thereof,

Whereas:

- (1) Commission Delegated Regulation (EU) 2021/340 of 17 December 2020 amending Delegated Regulations (EU) 2019/2013, (EU) 2019/2014, (EU) 2019/2015, (EU) 2019/2016, (EU) 2019/2017 and (EU) 2019/2018 with regard to energy labelling requirements for electronic displays, household washing machines and household washer-dryers, light sources, refrigerating appliances, household dishwashers, and refrigerating appliances with a direct sales function¹ is to be incorporated into the EEA Agreement.
- (2) Annexes II and IV to the EEA Agreement should therefore be amended accordingly, HAS ADOPTED THIS DECISION:

Article 1

The following is added in points 4v (Commission Delegated Regulation (EU) 2019/2013), 4w (Commission Delegated Regulation (EU) 2019/2014), 4x (Commission Delegated Regulation (EU) 2019/2015), 4y (Commission Delegated Regulation (EU) 2019/2016), 4z (Commission Delegated Regulation (EU) 2019/2017) and 4za (Commission Delegated Regulation (EU) 2019/2018) of Chapter IV of Annex II to the EEA Agreement:
