DECISION OF THE EEA JOINT COMMITTEE No 209/2022

of 8 July 2022

amending Annex V (Free movement of workers) and Annex VIII (Right of establishment) to the EEA Agreement [2023/626]

THE EEA JOINT COMMITTEE,

Having regard to the Agreement on the European Economic Area ("the EEA Agreement"), and in particular Article 98 thereof,

Whereas:

- (1) Commission Implementing Decision (EU) 2022/724 of 10 May 2022 establishing the equivalence, for the purpose of facilitating the right of free movement within the Union, of COVID-19 certificates issued by the Republic of Seychelles to the certificates issued in accordance with Regulation (EU) 2021/953 of the European Parliament and of the Council (¹) is to be incorporated into the EEA Agreement.

HAS ADOPTED THIS DECISION:
