### SUBCOMMITTEE I ON THE FREE MOVEMENT OF GOODS

#### LIST OF ACQUIS SUBJECT TO SIMPLIFIED PROCEDURE

##### To be noted by the EEA Joint Committee

1. Simplified procedures<sup>1</sup> have been introduced in the food and veterinary field<sup>2</sup>. These procedures imply that certain acts are applicable to the EEA EFTA countries without being incorporated into the EEA Agreement. In this way, the EEA EFTA States will, simultaneously with the European Commission, take corresponding measures on the basis of relevant Union acts. The Union decisions may be taken note of by the EEA Joint Committee. These acts are not to apply to Liechtenstein.
2. In the Veterinary field, the procedures apply to application texts and lists of establishments related to import from third countries and to safeguard and protective measures. As to emergencies for food and feed of European Union origin or imported from a third country, Art. 53 and 54 of Regulation (EC) No 178/2002 apply.
3. The EEA Joint Committee is invited, at its meeting on 14 February 2014, to take note of 7 EU acts published in the Official Journal of the European Union in the fourth quarter of 2013 in the veterinary field (Annex I). There are two EU acts adopted in accordance with Articles 53 and 54 of Regulation No 178/2002 (Annex II) as of the entry into force on 1 May 2010 of Joint Committee Decision No 134/2007.
