To be noted by the EEA Joint Committee

1. Reference is made to paragraphs 7 and 8¹ in the Introductory Part of Chapter I of Annex I to the EEA Agreement, which lay down for simplified procedures for the handling of application texts, lists of establishments and safeguard and protective measures, all concerning imports from third countries.
2. The EEA Joint Committee will be invited to take note of 49 EC acts published in the Official Journal of the European Communities in 2000 (**Annex I**) and 90 EC acts published in 2001 (**Annex II**), altogether 139 EC acts.
