**SUBCOMMITTEE I ON THE FREE MOVEMENT OF GOODS**

**LIST OF VETERINARY ACQUIS SUBJECT TO SIMPLIFIED PROCEDURES**

**To be noted by the EEA Joint Committee**

1. A simplified procedure<sup>1</sup> has been introduced in the veterinary field<sup>2</sup>. The procedure implies that certain acts are taken note of by the EEA Joint Committee instead of being incorporated into the EEA Agreement. The procedure applies to application texts and lists of establishments related to imports from third countries and to safeguard and protective measures.
  
2. The EEA Joint Committee is invited, at the meeting on 10 June 2005, to take note of 93 EC acts and 16 corrigenda published in the Official Journal of the European Union in 2004 (Annex).
