(Adopted on 21 November 2018)

AMENDMENT TO ANNEX I TO THE AGREEMENT
REFERRED TO IN SUB-PARAGRAPH 1(a) OF ARTICLE 2
PRODUCTS NOT COVERED BY THE AGREEMENT

THE JOINT COMMITTEE,

Noting that amendments to Protocol A to the Agreement between the EFTA States and Israel (hereinafter referred to as “the Agreement”) require adjustments to Annex I to the Agreement,

Having regard to Article 30 of the Agreement, empowering the Joint Committee to amend the Annexes to the Agreement,

DECIDES:

1. The text of Annex I to the Agreement shall be replaced with the text as set out in the Annex to this Decision.
 2. This Decision shall enter into force on the first day of the third month after the instruments of ratification or acceptance have been deposited by the Parties with the Depositary, which shall notify the Parties.
 3. The Secretary-General of the European Free Trade Association shall deposit the text of this Decision with the Depositary.
