

APPENDIX I TO ANNEX C<sup>1</sup>

PRODUCT-SPECIFIC RULES

**Section A: General Interpretative Notes**

Article 1

*General Interpretative Notes*

1. For the purposes of interpreting the rules of origin set out in this Appendix, the following principles of interpretation shall apply:

- (a) The definitions set out in Article 1 of Annex C shall also apply to this Appendix;
- (b) The specific rule, or specific set of rules, that applies to a particular heading, subheading or group of headings or subheadings is set out immediately adjacent to that heading, subheading or group of headings or subheadings;
- (c) A requirement of a change in tariff classification or any other condition set out in a specific rule applies only to non-originating materials;
- (d) The expression “a change from any other heading” or “a change from any other subheading” means a change from any other heading (or subheading) of the Harmonized System, including, where applicable, any other heading (or subheading) within the group of headings (or subheadings) to which the rule is applicable;
- (e) The expression “a change from any heading outside that group” or “a change from any subheading outside that group” means a change from any other heading (or subheading) of the Harmonized System, except from any other heading (or subheading) within the group of headings (or subheadings) to which the rule is applicable;
- (f) The expression
  - “a change from within that heading”,
  - “a change from within that subheading”,
  - “a change from within any one of these headings”,

- “a change from within any one of these subheadings”,
- “a change to [a product] of [a tariff provision] from within that [tariff provision]”, or
- “a change to [a product] of any one of [tariff provisions] from within that [tariff provision]”,

means a change from any other product or material of that same heading (or subheading) of the Harmonized System; and

- (g) Where two or more rules are applicable to a heading, subheading or group of headings or subheadings and the alternative rule contains a phrase commencing with the words “whether or not”,
  - (i) the change in tariff classification specified in the phrase commencing with the words “whether or not” reflects the change specified in the first rule applicable to the heading, subheading or group of headings or subheadings;
  - (ii) the only change in tariff classification permitted by the alternative rule, in addition to the change in tariff classification specified at the beginning of that rule, is the change specified in the phrase commencing with the words “whether or not”;
  - (iii) unless otherwise specified, only the value of the non-originating materials referred to at the beginning of the alternative rule, and specified again in the phrase commencing with the words “provided that the value of the non-originating materials”, shall be included in calculating the value of non-originating materials; and
  - (iv) the value of any non-originating materials satisfying the change of tariff classification specified in the phrase commencing with the words “whether or not” shall not be included in calculating the value of non-originating materials.

2. A product-specific rule of origin set out in this Appendix represents the minimum amount of production required to be carried out on non-originating materials for the resulting product to achieve originating status. A greater amount of production than that required by the rule for that product shall also confer originating status.

3. For cases where a rule of this Appendix applicable to a product contains both a required change in tariff classification and a percentage for the maximum value of non-originating materials, a tolerance for non-originating materials has been foreseen in paragraph 1 of Article 5 of Annex C. The use of non-originating materials which do not satisfy the tariff change requirement is in such cases permitted under the following conditions:

- (a) The value of such materials does not exceed 10 % of the transaction value or ex-works price of the product; and

- (b) The percentage for the maximum value of non-originating materials as set out in the rule may not be exceeded through the use of the tolerance provision; the value of such non-originating materials shall be included when calculating the value of non-originating materials.
4. (a) Paragraph 2 of Article 4 of Annex C may be applied in cases in which:
- (i) a rule of this Appendix applicable to a product contains both a required change in tariff classification and a percentage for the maximum value of non-originating materials; and
  - (ii) one or more of the non-originating materials used in the production of the product are classified under the same subheading, or heading that is not further subdivided into subheadings, as the product itself.
- (b) Paragraph 2 of Article 4 of Annex C provides that, in such instances, the product shall be considered as originating, if the value of the non-originating materials classified as or with the product does not exceed 40 % of the transaction value or ex-works price of the product.
- (c) According to paragraph 4 of Article 4 of Annex C, given that the resulting product qualifies as originating in its own right, no account shall be taken of the non-originating materials contained therein when that product is used in the production of another product. In this particular instance, only the value of any other non-originating materials that are used in the production of the final product and that satisfy the required change in tariff classification set out in the rule of this Appendix would need to be taken into account when calculating the value of non-originating materials for purposes of determining the originating status of the final product.
5. The product-specific rules set out in this Appendix also apply to used products.

## Article 2

### ***Review***

1. In order to facilitate trade further, the Parties shall, no later than four years after the date of entry into force of this Agreement, or at an earlier request of a Party, explore whether product-specific rules are required for the products of Chapter 2 of the Harmonized System, Meat and edible meat offal.

2. The Parties shall, no later than four years after the date of entry into force of this Agreement, review the product-specific rules with respect to printing, dyeing, coating and embroidering of textile fabrics, and with respect to bed linen of Harmonized System subheading 6302.10 through 6302.39. In this review, the Parties shall take into account changed circumstances, such as technological advances, changes in market conditions and developments at the World Trade Organization with respect to international trade in textiles.

Vacuum distillation is useful for distilling high-boiling and heat-sensitive materials such as heavy distillates in petroleum oils to produce light to heavy vacuum gas oils and residuum. In some refineries gas oils may be further processed into lubricating oils;</i></p> <p><b>(c) Catalytic hydroprocessing</b> <i>The cracking and/or treating of petroleum oils with hydrogen at high temperature and under pressure, in the presence of special catalysts. Catalytic hydroprocessing includes hydrocracking and hydrotreating;</i></p> <p><b>(d) Reforming (catalytic reforming)</b> <i>The rearrangement of molecules in a naphtha boiling range material to form higher octane aromatics (i.e., improved antiknock quality at the expense of gasoline yield).
