On 7 January 2010, the Norwegian Government appointed a broad-based independent committee to undertake a thorough, research-based review of the EEA Agreement.


The mandate of the Committee called for a comprehensive and thorough review of the political, legal, administrative, economic and other social consequences of the EEA Agreement.







INCREASING NUMBER OF AGREEMENT


ANTALL GJELDENDE AVTALER MED EU, ETTER INNGÅELSESTIDSPUNKT (KUMULATIV OVERSIKT)






LEGAL ACTS FIGUR 6.3 UTVIKLINGEN AV ANTALL RETTSAKTER I EØS OVER TID





Comprehensive

More extensive than people are aware of

Estimate: ¾ of the total EU cooperation (compared with member states that are most integrated)

Efficient implementation and compliance



NON-CONTROVERSIAL

EU membership issue – controversial

EEA and Norway's agreements with the EU – a convinient compromise

- 287 votes in the Storting 265 unanimous
- 17 potential cases of «veto» never used
- All governmental platforms based on the agreements
- Consistent policy

PROTECTING INTERESTS AND VALUES

1992-2011 – a golden era

Difficult to distinguish the EEA effects

DEMOCRATIC CHALLENGES

A solid domestic and parlamentary base

- Role of judiciary is strenghtened but at the expence of representative institutions


