DECISION OF THE JOINT EFTA-ISRAEL COMMITTEE

No. 4 of 1993

(Adopted at the first meeting on 11 and 12 November 1993)

AMENDMENTS TO, AND CORRECTIONS OF TECHNICAL ERRORS IN, ANNEXES AND PROTOCOLS TO THE AGREEMENT

THE JOINT COMMITTEE,

Noting that some technical errors are contained in the Annexes and Protocols,

Noting that the Swiss Government has deleted cinematograph film (ex HS heading 37.06) from their list of products subject to fiscal duties in Protocol C,

Noting that Finland shall abolish its present regime for the import of certain fish products by 1 January 1997,

Having regard to Article 30 empowering the Joint Committee to amend the Annexes and Protocols to the Agreement,

DECIDES:

1. In Table II to Protocol A
