DECISION OF THE JOINT EFTA-MACEDONIA COMMITTEE

No. 2 of 2008

(Adopted on 28 November 2008)

AMENDMENTS TO PROTOCOL A CONCERNING PROCESSED AGRICULTURAL PRODUCTS

THE JOINT COMMITTEE,

Noting that according to paragraph 2 of Article 3 of Protocol A, the EFTA States shall, based on reviews, accord to products listed in Tables II-IV to the Protocol, originating in Macedonia, treatment not less favourable than that accorded to the European Community,

Noting that according to Article 4 of Protocol A, Macedonia shall, for products listed in Table V to the Protocol, originating in an EFTA State, accord treatment not less favourable than that accorded to the European Community,

Noting further that according to Article 6 of Protocol A the EFTA States and Macedonia shall review periodically the development of their trade in products covered by the Protocol,

Taking into account that the EFTA States have revised their agreements with the European Community on processed agricultural products, by expanding the product coverage of these agreements and providing for improved concessions for the products covered,

Recognising that Tables I-V in the Protocol will according to the Decision be replaced by Table I (for the EFTA States) and Table II (for Macedonia),

Having regard to Article 33 of the Agreement, empowering the Joint Committee to amend Protocols of the Agreement,

DECIDES:

- 1. Protocol A and Tables I, II (Iceland), III (Liechtenstein, Switzerland), IV (Norway) and V (Macedonia) to the Protocol shall be replaced by the text and Tables set out in the Annex to this Decision.
- 2. Taking into account that this Decision requires approval through further internal procedures in Macedonia and Norway, it shall enter into force on the first day of the third month after the last of these Parties has deposited its instruments of acceptance with the Depositary, which shall notify all the Parties.
- 3. The Secretary-General of the European Free Trade Association shall deposit the text of this Decision with the Depositary.

PROTOCOL A

REFERRED TO IN SUB-PARAGRAPH (b) OF ARTICLE 2

PROCESSED AGRICULTURAL PRODUCTS

Article 1

- 1. In order to take account of differences in the cost of the agricultural raw materials incorporated in the products referred to in Article 2 of this Protocol, this Agreement does not preclude:
 - (a) the levying, upon import, of a duty;
 - (b) the application of measures adopted upon export.
- 2. The fixed duties, levied upon import, shall be based on, but not exceed, the differences between the domestic price and the world market price of the agricultural raw materials incorporated into the products concerned.

Article 2

- 1. For products listed in Table I, originating in Macedonia, Iceland, Liechtenstein/Switzerland and Norway respectively shall accord the concessions indicated in Table I.
- 2. Taking into account the provisions laid down in Article 1 of this Protocol, Iceland, Liechtenstein/Switzerland and Norway shall, based on reviews that can be held upon request, accord to products listed in Table I, originating in Macedonia, treatment not less favourable than that accorded to the European Community.

Article 3

For products listed in Table II, originating in an EFTA State, Macedonia shall accord treatment not less favourable than that accorded to the European Community.

Article 4

- 1. The EFTA States and Macedonia shall notify each other at an early stage, at least before the entering into force, of all measures applied under Article 1 of this Protocol.
- 2. Macedonia and the EFTA States shall inform each other of all changes in the treatment accorded to the European Community.

Article 5

The Parties shall review periodically the development of their trade in products covered by this Protocol. In the light of these reviews and taking into account the arrangements between the Parties in the WTO and between them and the European Community, the EFTA States and Macedonia shall decide on possible changes to the product coverage of this Protocol, as well as on a possible development of the measures applied under Article 1 of this Protocol.
