ANNEX III

THE JOINT COMMITTEE,

Noting that the amendments to the Nomenclature appended to the International Convention on the Harmonized Commodity Description and Coding System (HS) accepted as a result of the Customs Co-operation Council Recommendation of 25 June 1999 which entered into force on 1 January 2002, require adjustments in the HS structure of Annex III,

Having regard to Article 33 of the Agreement, empowering the Joint Committee to amend the Annexes of the Agreement,

DECIDES:

1. Lists A and B of Annex III shall be replaced with new Lists A and B of Annex III attached at Annex to this Decision.
 2. This Decision shall enter into force on 1 September 2003 provided that Macedonia by this date has notified the Depositary that its constitutional requirements for the entry into force of the Decision have been fulfilled.
 3. The Secretary-General of the European Free Trade Association shall deposit the text of this Decision with the Depositary.
