DECISION OF THE COUNCIL NO 4 OF 2009

(Adopted at the tenth meeting on 19 November 2009)

AMENDMENTS TO THE APPENDIX TO ANNEX Q TO THE CONVENTION AIR TRANSPORT

THE COUNCIL,

Having regard to the Member States' endeavour to regularly update the Convention in order to take account of developments under the Agreement on the European Economic Area and the Bilateral Agreements of 21 June 1999 between the Swiss Confederation on the one hand and the European Community and its Member States on the other,

Having regard to Article 53(3) of the Convention, empowering the Council to amend the Appendix to Annex Q to the Convention,

Having regard to the recommendation of the Committee on Air Transport in its report to the Council to amend the Appendix to Annex Q (Air transport) to the Convention,

DECIDES:

- 1. The Appendix to Annex Q to the Convention shall be amended as follows:
 - a) Point 1 (Third aviation package of liberalisation and other civil aviation rules) shall be amended as follows:

- (i) Under the reference to Council Regulation (EEC) No 2407/92, the words "Article 169 of the EC Treaty" shall be replaced by "Article 226 of the EC Treaty".
- (ii) The text regarding the reference to Council Regulation (EEC) No 2408/92 shall be replaced by the following:

'No 2408/92

Council Regulation of 23 July 1992 on access for Community air carriers to intra-Community air routes, as amended by:

- 1 03 T: Act concerning the conditions of accession of the Czech Republic, the Republic of Estonia, the Republic of Cyprus, the Republic of Latvia, the Republic of Lithuania, the Republic of Hungary, the Republic of Malta, the Republic of Poland, the Republic of Slovenia and the Slovak Republic and the adjustments to the Treaties on which the European Union is founded adopted on 16 April 2003 (OJ L 236, 23.9.2003, p. 33).

(Articles 1-10, 12-15)

The provisions of the Regulation shall, for the purposes of this Convention, be read with the following adaptation:

The Annexes to the Regulation shall include only airports in the EFTA States.'

'The provisions of the Directive shall, for the purposes of this Convention, be read with the following adaptation:

Switzerland shall apply the Directive after a transitional period of the same length as the implementation period laid down in the Directive for the Member States of the Community, running as of 1 June 2004.'

(v) The following text under the reference to Council Directive 93/104/EC shall be deleted:

'The provisions of the Directive shall, for the purposes of the Agreement, be read with the following adaptation:

Switzerland shall apply the Directive after a transitional period of the same length as the implementation period laid down in the Directive for the Member States of the Community, running as of 22 April 2004.'

(vi) The following shall be inserted after the reference to Council Directive 93/104/EC:

'No 785/2004

Regulation of the European Parliament and of the Council of 21 April 2004 on insurance requirements for air carriers and aircraft operators.'

b) The following shall be inserted in point 2 (Technical harmonisation) after the reference to Council Regulation (EEC) No 3922/91:
