

**Decision No 1/2025 of the Joint Committee established by the Separation Agreement
of 10 June 2025**

amending Part I of Annex I to the Separation Agreement

THE JOINT COMMITTEE,

Having regard to the Separation Agreement¹, and in particular Articles 34(3) and 66(1) thereof,

Whereas:

- (1) Pursuant to Article 34(3) of the Separation Agreement, the Joint Committee shall amend Part I of Annex I to reflect any new Decision or Recommendation which has been adopted by the Administrative Commission for the Coordination of Social Security Systems ("Administrative Commission") and which has been incorporated into and is in force under the EEA Agreement.
- (2) The Administrative Commission has adopted one Decision which has been incorporated into and is in force under the EEA Agreement, and which is not listed in Part I of Annex I to the Separation Agreement.
- (3) Part I of Annex I to the Separation Agreement should therefore be amended accordingly,

HAS ADOPTED THIS DECISION:

Article 1

The following Decision is added in Part I of Annex I to the Separation Agreement under Horizontal issues (H series):

- Administrative Commission for the Coordination of Social Security Systems Decision No H14 of 21 June 2023 concerning the publication of the Guidance note on COVID-19 pandemic, the note on the interpretation of the application of Title II of Regulation (EC) No 883/2004 and Articles 67 and 70 of Regulation (EC) No 987/2009 during the COVID-19 pandemic, the Guidance note on telework applicable for the period between 1 July 2022 and 30 June 2023 and the Guidance note on telework applicable from 1 July 2023 (OJ C, C/2024/594, 11.1.2024)².

Article 2

This Decision shall enter into force on the day of its adoption. In relation to Liechtenstein, this Decision shall enter into force on the first day of the second month following its notification to the Depositary that its domestic legal requirements have been fulfilled.
